With reference to item 'h' above, in accordance with subclause 5.1.2 of the Club's Constitution, all positions of the Committee are declared vacant on the day and the Committee of the Club for the season 2022 will be elected. Nominations for positions of the committee can be made in writing to the Secretary at any time prior to the AGM or can be made verbally in person to the Secretary at the AGM. If you are unable to attend the AGM but would like to nominate, or if you are unable to attend but would like to vote, you must use the attached Nomination & Proxy form. The nomination and appointment of proxy processes are explained on the form.
