### **Information Regarding Nominations and Voting**

- All positions are declared vacant on the day as stated in subclause 5.1.2 of the Club Constitution.
- Nominations can be made in writing to the Secretary on this form at any time prior to the AGM, or can be made verbally in person to the Secretary at the AGM. The form can be posted to the club's postal address or delivered by arrangement to the secretary.
- Please note that whilst postal *nominations* for positions (on this form only) will be accepted, postal *votes* will not be accepted - subclause 4.3.12 states "Postal votes will not be accepted for any resolutions or elections at the AGM."
- To vote on the nominees for committee, you must attend the AGM in person or appoint a proxy. Please also note that subclause 4.3.13 states "A limit of one Proxy vote can be appointed to any Member to vote on any resolutions or elections at the AGM." This member must attend the AGM to utilise the proxy vote. (i.e.: A single member can make their own vote for each position or motion and vote as one proxy for each position or motion.)
- In accordance with subclause 5.1.6 of the club's constitution the parents/guardians of Junior Playing Members and Life Members of the Club are entitled to vote at an AGM and only one vote is allowed per member present at the AGM. Please note that both parents/guardians of Junior Playing Members are entitled to one vote each, regardless of the number of Junior Playing Members they have registered with the Club.
- If you are unable to attend the AGM but would like to nominate, please use this nomination form.
- If you are unable to attend but would like to vote, please use this proxy form to appoint a proxy. The proxy is authorised to vote at their own discretion so your voting preference should be communicated to them prior to the AGM.
- If the proxy form is signed but no proxy is specified, then the proxy is deemed invalid.
- This form should be completed with due care and consideration and must be signed at the bottom of each completed section. Any unsigned section of this form will be deemed invalid.
- Every person nominated must personally consent to such nomination, either in writing to the Secretary prior to the AGM or in person to the Secretary at the AGM. If the nominee is unable to attend the AGM in person to consent to their nomination, they must provide their acceptance of the nomination in writing to the Secretary prior to the AGM. If written acceptance has not been received, then the Secretary will deem that the nomination has not been accepted.

  - Canteen Manager

Candidates for these positions are advised and determined at any General Committee Meeting following the AGM and are not elected at the AGM.
